#### Ganpati Educational Society (GES) Contributes to Groundbreaking Himalayan Flood Database Workshop

On June 5, 2024, GES participated in a pivotal workshop at Himachal Pradesh University, focusing on the UGC-UKIERI project HiFlo-DAT - a comprehensive Indian Himalayan Flood Database for Disaster Risk Reduction. This UKINDIA Education and Research Initiative event showcased a pioneering database documenting over 100 historical floods in Kullu District from 1846-2020, particularly relevant given the district's recent floodlandslide events in summer 2023.

The workshop united diverse stakeholders, including government agencies, NGOs, archivists, media organizations, research funders, and academics. Discussions centered on the database's applications, its potential for expansion across the Indian Himalaya, and strategies for maintaining an open-access resource.

Importantly, this initiative aligns with UN Sustainable Development Goals and contributes to national and regional disaster risk reduction targets. By systematically capturing disaster loss data, it aims to enhance local-level disaster management strategies.

GES was represented by Dr. Roshan Sharma (Director) and Dr. Daman Ahuja (Public Health Expert), underlining the organization's commitment to disaster preparedness and community resilience. The event, inaugurated by the Officiating Vice Chancellor of Himachal Pradesh University, featured notable speakers including Associate Prof. Richard Johnson (Cumbria University, UK) and Prof. Devdutt Sharma (Himachal Pradesh University).

This collaborative effort marks a significant step towards improved flood risk management in the Himalayan region, with potential far-reaching impacts on policy, research, and community safety.
